Eligible entrants: Entry is only open to Queensland residents who are 18 years and over. Employees (and their immediate family members) of Yamanto Central shopping centre, its management, retailers, contractors, agents, and staff are not permitted to enter.

Participants must fully complete and submit the entry form with their personal details (first name, last name, email address, phone number, postcode). Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the entrant. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorized intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.
18. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including the entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered.
